### Agenda and Meeting Goals

 The goal of agenda and meeting was to update the Technical Advisory Group (TAG) on where implementation of the 1W1P is at currently and to help guide the CRWJPB on the next workplan priorities

# Implementation Updates

Ashley Gallagher presented a power point on the current activities and progress, along with those in the
workplan for 2022. A discussion was had on how the group choose which lake to start lake management
plans on and why the group had chosen impaired lakes before protected lakes.

#### Ranking of activities for 2023-2024

- The priority concerns were voted on and the results from highest votes to least for the top five were:
  - Lakes, Streams, and Rivers
  - Agriculture
  - Groundwater, Wetlands, and Drainage Systems
- Lakes, Streams, and Rivers were voted on and the results for the highest votes were implementation activities: 3.1.1-B-3, and a tie for second between 3.1.1-A-1, 3.1.1-A-3, and 3.1.1-B-1.
- Agriculture was voted on and the results for the highest votes were implementation activities: 3.2.1-A-1, and a tie for second between 3.2.1-A-3 and 3.2.1-B-2.
- Groundwater was voted on and the results for the highest votes were implementation activities: a tie between 3.1.3-A-3 and 3.1.3-A-9, and followed by 3.1.3-A-4. Jennifer from MDH has resources and grants that would help with these activities, along with MDA would also.
- Drainage Systems were voted on and the results for the highest votes were implementation activities:
   3.2.1-A-8, 3.2.3-A-9, and 3.2.3-A-3 and 3.2.3-A-7. The discussion around these is they can take a long time to accomplish and the possibility of re-evaluating areas and priorities when the new PTMapp comes out.
- Wetland were voted on and the results for the highest votes were implementation activities: 3.1.2-A-1, as this is the only activity in this category at the current time.

## Discussion of Gaps

• The TAG didn't not see any gaps other than what was mentioned during the ranking portion.

#### Other funding sources

- MPCA brought up the 319 grants for future funding sources.
- Other sources would be to look to partnering with those agencies present on current programs for equipment use, technical assistant, and overlapping programs that would fulfill implementation activities.
